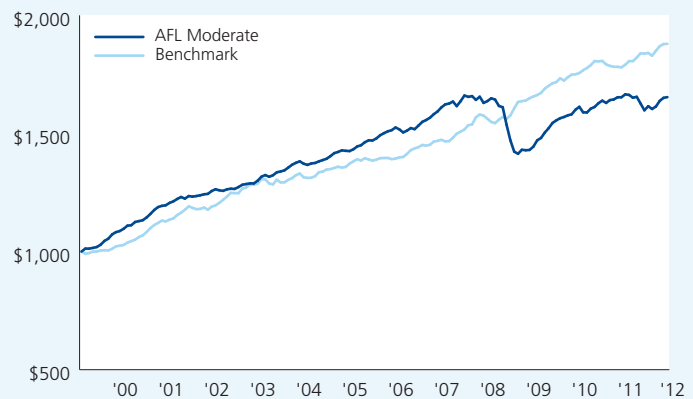

GROWTH OF \$1,000 VS. BENCHMARK



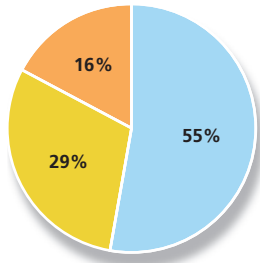

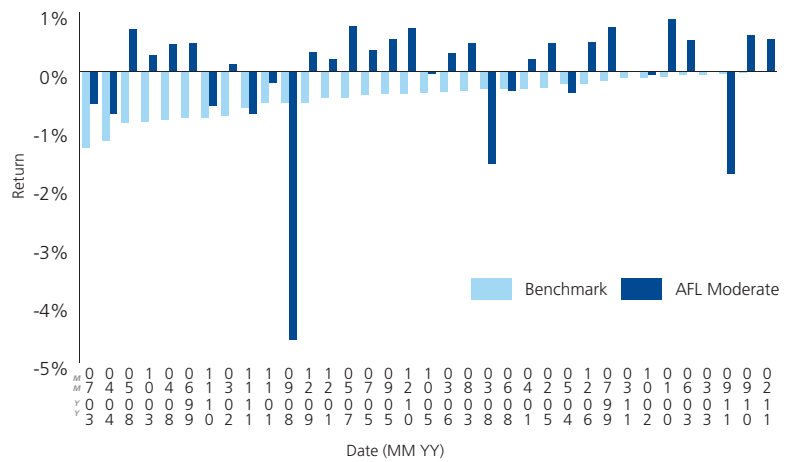

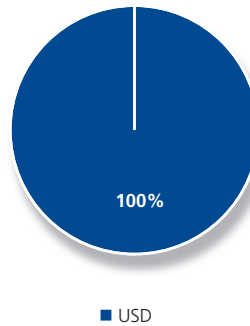

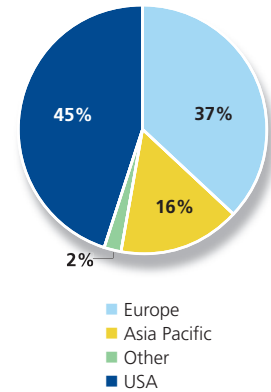
AFL MODERATE VS BENCHMARK - DOWN MONTH PERFORMANCE
